(1). That the residence of your Petitioners is 38 Mill Road Trailer Court, Clearfield, Pennsylvania.

(2). That Clyde Raymond Norris was born April 18, 1931, in Pike Township, Clearfield County, Pennsylvania, Certification of Birth No. 370693 being attached hereto and marked Exhibit "A".

(3). That your Petitioner, Clyde Raymond Norris, has obtained employment in Baltimore, Maryland, which will require establishment of his birth record to obtain the necessary security clearance for his employment.

(4). That your Petitioner, Clyde Raymond Norris, commutes to his work, returning to his home in Clearfield, Pennsylvania, on weekends.

(5). That your Petitioners desire that their name be changed from Clyde Raymond Norris and Marie Smith Norris to Clyde Raymond Peters and Marie Smith Peters for the following reasons:

A. That your Petitioners have always been known as and used the names Clyde Raymond Peters and Marie Smith Peters.

B. That the employment of Clyde Raymond Norris requires the submission of a birth record, and submission of a record in the name of Clyde Raymond Norris will add

confusion and difficulty to his employment as he was hired under the name of Clyde Raymond Peters.

C. That Clyde Raymond Norris has always previously believed his name to be Clyde Raymond Peters and used such name on all legal papers.

D. That the school records of Clyde Raymond Norris are under the name of Clyde Raymond Peters.

E. That the military service records of Clyde Raymond Norris are under the name of Clyde Raymond Peters.

F. That the employment records of Clyde Raymond Norris are under the name of Clyde Raymond Peters.

G. That all social security and income tax records of Clyde Raymond Norris are under the name of Clyde Raymond Peters.

H. That all insurance of Clyde Raymond Norris is under the name of Clyde Raymond Peters.

I. That Clyde Raymond Norris was married to Marie Elizabeth Smith under the name of Clyde Raymond Peters and the marriage record is in the name of Clyde Raymond Peters.
