I/WE JOINTLY AND SEVERALLY PROMISE TO PAY TO ENTERPRISE CONSTRUCTION COMPANY  
(Name of Dealer/Contractor)

OR ORDER THE SUM OF TWO THOUSAND SIX HUNDRED THIRTY TWO AND 20/100 DOLLARS  
IN 60 SUCCESSIVE MONTHLY INSTALMENTS OF \$ 41.67 EACH, EXCEPT THAT THE FINAL INSTALMENT SHALL BE THE BALANCE THEN DUE ON THIS

NOTE, COMMENCING THE 15 DAY OF Aug, 1961, AND THE SAME DATE OF EACH MONTH THEREAFTER UNTIL PAID, with interest after maturity at the highest lawful rate, and a reasonable sum (15% if permitted by law) as attorney's fees, if this note is placed in the hands of an attorney for collection after maturity.
