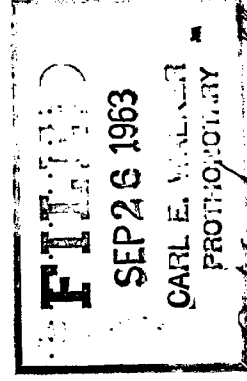

The undersigned does hereby empower any attorney of any Court of record, within the Commonwealth of Pennsylvania or any other State or Territory of the United States to appear for the undersigned and with or without declaration filed, confess judgment against the undersigned in any Court in the Commonwealth of Pennsylvania or any other State or Territory of the United States, as of any term, in favor of said payee or any holder of this note, for the sum due and payable thereon with costs of suit and attorney's commission of fifteen per cent for collection; with release of all errors and without stay of execution, and inquisition and extension upon any levy is hereby waived and condemnation agreed to, and the exemption of all property from levy and sale on any execution hereon is also hereby expressly waived and no benefit of exemption is to be claimed under and by virtue of any exemption law now in force or which may be hereafter passed by any State or Nation. The maker's of this note, when more than one, shall be jointly and severally liable hereon.
