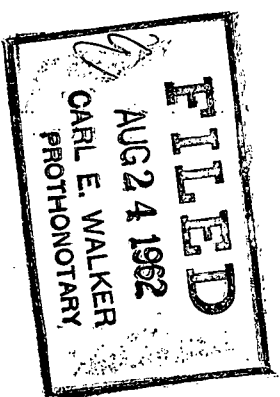

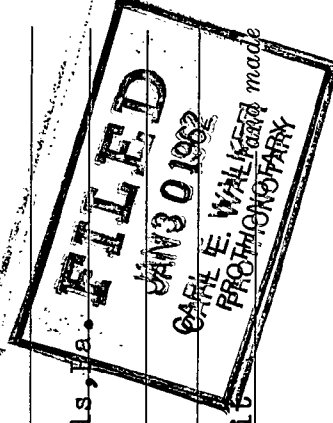


COMPLAINT

1. Plaintiff herein is an individual residing in Madera, Clearfield County, Pennsylvania.
2. Defendant is an individual residing at 315 Stone Street, Osceola Mills, Pennsylvania.
3. That on or about December 13, 1960 at approximately 3:30 o'clock P. M. the plaintiff was operating a 1959 Oldsmobile owned by her in a southerly direction on Water Street in the Borough of Philipsburg, Pennsylvania.
4. That at the date and time aforesaid the defendant herein was operating his motor vehicle in a northerly direction on Water Street when he collided with the plaintiff herein.
5. That at the time and place aforesaid the defendant was operating his vehicle in the middle of the street and failed to yield the right of way to the vehicle of the plaintiff causing the collision referred to herein.
6. That in the operation of his motor vehicle the defendant was negligent in the following respects:
 - (a) In failing to yield one-half of the highway to a vehicle approaching in the opposite direction.
 - (b) In driving at a speed that was high and excessive under the circumstances.
 - (c) In failing to have his vehicle under such control that he could stop within the assured clear view.

(d) In otherwise failing to regard the lawful rights of other users of the highway.

6. That as a result of the aforesaid accident the plaintiff's vehicle was severely damaged and required the expenditure of \$1,051.34 to repair said damages. The said damages being more fully set forth in copy of the repair bill, Exhibit "A", attached hereto and made a part hereof.

WHEREFORE, plaintiff brings this suit to recover the sum of \$1,051.34.
