RELEASE FROM LIEN OF JUDGMENT

WHEREAS, THE UNION BANKING AND TRUST COMPANY, of DuBois, Pennsylvania, has obtained a Judgment in the Court of Common Pleas of Clearfield County, Pennsylvania, against HOWARD E. ZERBE and LEONA E. ZERBE, husband and wife, both of Sandy Township, Clearfield County, Pennsylvania, at No. 518 November Term, 1961, in the principal sum of Twelve Thousand and Seven Hundred Dollars (\$12,700.00) dated January 15, 1961 and entered on January 18, 1961, which Judgment remains a lien on all the real estate of the said Defendants within said Clearfield County; and

WHEREAS, the said Defendants have requested that all that certain piece or parcel of land situated in Sandy Township, Clearfield County, Pennsylvania, and being bounded and described as follows, to wit:

BEGINNING at an iron spike in the center line of Kiwanis Trail, said spike being the Northwest corner of the tract of land owned by the Grantors herein, and purchased from Donald McCreight et al. by deed dated October 17, 1959; thence South 10° 34' West, 200 Feet to an iron pipe; thence South 79° 27' East 118 Feet to an iron pipe; thence North 10° 34' East 200 Feet to the center line of Kiwanis Trail; thence North 79° 26' West 118 Feet along said center line of Kiwanis Trail to a point and place of beginning;

which was conveyed to Howard E. Zerbe and Leona E. Zerbe by Donald McCreight, et al., by their deed dated October 17, 1959 and recorded at Clearfield, Pennsylvania, in Deed Book No. 479, page 377, be exonerated and discharged from the lien and operation of the Judgment aforesaid.



KNOW ALL MEN BY THESE PRESENTS, that the UNION BANKING AND TRUST COMPANY, of the City of DuBois, County of Clearfield and State of Pennsylvania, for and in consideration of the sum of One (\$1.00) Dollar does hereby release and discharge from the lien of the above stated judgment, ALL those certain pieces or parcels of land situate, lying and being in the Township of Sandy, Clearfield County, Pennsylvania, being bounded and described as follows, to wit:

THE FIRST THEREOF: BEGINNING at an iron pipe Fifty (50) feet west of an iron pipe, the southeast corner of land of Ralph Shaffer, being the west corner of the so-called Bogert lot, said pipe being Sixteen and one-half (16½) feet South of center of Kiwanis Trail; thence South 10°34' West three hundred (300) feet to an iron pipe; thence along lands of M. 




