





2. The Plaintiff is residing at 18 E. Sherman Avenue, DuBois, Clearfield County, Pennsylvania.
3. The Defendant is residing at R. D. (Clear Run), DuBois, Clearfield County, Pennsylvania.
4. Both the Plaintiff and the Defendant are citizens of the United States, and residents of the State of Pennsylvania.
5. The Plaintiff and Defendant were married on May 26, 1950 at Pittsburgh, Allegheny County, Pennsylvania.
6. There were three children born as a result of this marriage; Nelda Lee, age 9 years; Gary E., age 6 years and Allan Richard, age 4 years, all of whom reside with the Plaintiff.
7. Plaintiff avers that the Defendant, in violation of his marriage vows, and of the laws of the Commonwealth of Pennsylvania, did offer such indignities to the person of the Plaintiff, as to render her life burdensome and her condition intolerable.
8. That neither party has instituted prior divorce

proceedings in this or any other county, and that there is not now pending any divorce proceedings between the parties.


9. This action is not collusive.

MASTER'S REPORT

TO THE HONORABLE JOHN J. PENTZ, PRESIDENT JUDGE OF SAID COURT:

The undersigned Commissioner appointed by your Honorable Court to take testimony and report the same with form of decree in the above entitled action respectfully represents:

I. COMMISSION.

(Hereunto attached).

II. DOCKET ENTRIES AND SCHEDULE

1. Complaint in Divorce filed on April 19, 1961.
2. On April 24, 1961, at 9:35 o'clock A.M., E.S.T., Alex Campbell, Constable, served the within Complaint in Divorce on RICHARD L. MAY, by handing to him personally, a certified copy of said Complaint in Divorce at his place of business, DuBois Tool and Electric Supply Company, DuBois, Pennsylvania.

3. On April 24, 1961, on praecipe filed by William C. Chase, Attorney, entered his appearance for the Defendant and waived the time for filing an answer.

4. On May 3, 1961, by Motion on the Watch Book, Anthony S. Guido, Esq., was appointed Master to take the testimony and report the same with form of decree.

5. May 8, 1961, Master's hearing set for Friday, May 19, 1961 at 10:30 A.M. in the office of Gleason, Cherry & Cherry, 109 North Brady Street, DuBois, Pennsylvania.

6. On May 8, 1961, service of notice of Master's hearing accepted and Fifteen (15) days notice as required by Clearfield County Court Rule 11 (9) waived by David E. Blakley, Esq., counsel of record for the Plaintiff.

7. On May 9, 1961, service of notice of Master's hearing accepted and Fifteen (15) days notice as required by Clearfield County Court Rule 11 (9) waived by William C. Chase, Esq., counsel of record for the Defendant.

8. That the time and place for hearing having arrived, there appeared before your Master the following: MILDRED Y. MAY, Plaintiff; DONALD GRAHAM, Witness for Plaintiff; and David E. Blakley, Attorney for Plaintiff. No appearance was entered by or on behalf of said Defendant.

III. COMPLAINT AND FILED PAPERS.

IV. CAUSES OF DIVORCE.

Indignities to the person.

V. FINDINGS OF FACT.

1. Marriage - the said Plaintiff and Defendant were married on the 26th day of May, 1950 at Pittsburgh, Pennsylvania.

2. Residence - the Plaintiff and Defendant have resided in the Commonwealth of Pennsylvania all of their lives. The present residence of the Plaintiff being 18 East Sheridan Avenue, DuBois, Clearfield County, Pennsylvania, and the present residence of the Defendant is Clear Run, Sandy Township, Clearfield County, Pennsylvania.

3. Citizenship - the Plaintiff and Defendant are both natural born citizens of the United States.

4. Age and occupation - the Plaintiff is 36 years of age and is unemployed. The Defendant is 32 years of age and is the Secretary-Treasurer of Erickson Corporation, DuBois, Pennsylvania.

5. Children - There were three children born to this marriage, namely, Nelda May, age 9; Gary May, age 6; and Allan May, age 4.

6. Armed Forces - Neither the Plaintiff nor the Defendant is a member of the Armed Forces of the United States.

7. Findings on the Merits and Discussion - it appears from the evidence that this Defendant disregarded all obligations of his marriage. The difficulties between them commenced approximately nine months prior to hearing, and continued to the present. He continuously and publicly kept company with another woman, paying no attention to Plaintiff whatever. His "running-around" has been common talk among the folks of the community; and all of these matters were such as to embarrass Plaintiff to a point where Plaintiff's life became burdensome. Although frequently the Plaintiff requested him to refrain from his illicit relationship, he refused to do so. The evidence establishes that Defendant's actions were such as to make Plaintiff's life burdensome and living together intolerable.

In the opinion of your Master therefor, good and sufficient grounds for divorce have been established by the evidence.

VI. CONCLUSIONS OF LAW.

1. Your Commissioner finds that the proceedings in this action are in accordance with the requirements of law and rules of court.

2. The Court has jurisdiction of the action and the parties.

3. Good and sufficient grounds for divorce has been established by the evidence.

VII. RECOMMENDATIONS

Your Master recommends that a divorce be granted to the Plaintiff and against the Defendant on the grounds of Indignities to the Person of the Plaintiff.

MILDRED Y. MAY being duly sworn according to law, testified as follows:

BY MR. BLAKLEY:

Q. Would you state your name ?

A. Mildred Y. May.

Q. And where do you reside ?

A. 18 E. Sherman Avenue.

Q. In DuBois ?

A. Yes.

Q. And are you married ?

A. Yes.

Q. To whom ?

A. Richard L. May.

Q. When and where were you married ?

A. In Pittsburgh, Pa., May 26th, 1950.

Q. Are you a citizen of the United States ?

A. Yes.

Q. Were you born here ?

A. Yes.

Q. Were you born in Pennsylvania ?

A. Yes.

Q. Do you know if your husband was born in Pennsylvania ?

A. Yes, he was.

Q. At the time of your marriage, where did you reside ?

A. In Pittsburgh.

Q. Where did he reside ?

A. Uniontown.

Q. How long have you lived in Clearfield County ?

A. It was ten years in January.

Q. Where is your husband residing at the present time ?

A. Clear Run.

Q. Is that in Clearfield County ?

A. Yes, it is.

Q. Now then, has he resided in Clearfield County continuously for the last ten years too ?

A. Yes.

Q. Were there any children born as a result of this marriage ?

A. Yes, there were.

Q. Would you state their names and ages ?

A. Nelda is nine, Gary 6 and Allan, 4.

Q. With whom do they reside ?

A. With me.

Q. What is your age ?

A. Thirty-six.

Q. Are you employed ?

A. No, I'm not.

Q. What is your husband's age and occupation ?

A. Thirty-two and he is Secretary-Treasurer of the Erickson Corp.

Q. When is the last you have seen your husband ?

A. The other morning.

Q. In other words, within the last few days ?

A. Yes.

Q. At that time was he a member of the military service of the United States ?

A. No, he wasn't.

Q. Has he ever been a member of the military service ?

A. Yes he has.

Q. When, since you were married, or before ?

A. Before and after.

Q. Has he been a member of the military service within the last year ?

A. No.

Q. Is there any agreement between you and he that you are to get this divorce ?

A. No.

Q. Did you ever file any prior divorce actions ?

A. No.

Q. Has he ever filed any divorce actions ?

A. No.

Q. When did your difficulties first begin ?

A. In September of 1960.

Q. What was the nature of the difficulty ?

A. Well, he informed me that he was going with another woman ?

Q. He told you this ?

A. Yes, he did.

Q. Did you have any knowledge of it before that ?

A. No, I didn't.

Q. Why did he tell you ?

A. I suspected it, and came out and asked him, and he told me.

Q. This was in September of 1960, you say ?

A. Yes.

Q. Were you living together at that time ?

A. Yes, we were.

Q. Did he tell you how long he had been going with this other woman ?

A. Yes.

Q. How long had he ?

A. Well, he just met her on the 31st of August, and started dating her on the 1st of September.

Q. And this was the end of September he told you about it ?

A. No, the middle.

Q. What did he say about it ?

A. Well, he first said that he was going with someone, and he would like to have a divorce, and wanted me to marry someone else.

Q. Why did you suspect that he was going with someone else ?

A. Well, he had been out several nights until quite late, and I was in Pittsburgh for three days and when I came back he didn't pay any attention to me, didn't even kiss me all week,

Q. At that time was it general knowledge among your acquaintances and relatives that he was going around with this other woman ?

A. Definitely.

Q. And he is still going with her ?

A. Yes, he is.

Q. Everyone know it, do they ?

A. Yes.

Q. Are you separated from him now ?

A. Yes.

Q. When did you separate ?

A. October 27th.

Q. And has he openly gone with this other woman since that time ?

A. He has from the very beginning.

Q. Did you ever suggest to him that he should quit running around with this other woman ?

A. Yes, I did.

Q. What did he say to that ?

A. Oh, I don't know - it seemed that when you'd talk to him, he just sit there and stare into space, and have nothing to say.

Q. Did he ever promise that he would quit running with this other woman ?

A. Yes.

Q. But did he ?

A. No, he didn't.

Q. You say he is still openly running about with her ?

A. Yes, he is.

Q. Is his running with this other woman now, and before you were separated a source of great embarrassment to you ?

A. Yes, it is.

Q. Did it affect your health ? Make you nervous ?

A. Yes.

Q. And when you are among acquaintances and relatives, do you feel at ease, or is it extremely embarrassing to you everyone knowing this ?

A. Yes, it is.

Q. Did he ever state whether or not he was in love with this other woman ?

A. Oh, Yes.

Q. Did he state whether or not he still cared for your ?

A. No.

Q. Do you feel that the love upon which a marriage is based is completely gone here ? As far as he is concerned ?

A. Yes, definitely.

Q. Do you feel in the light of his conduct it would be impossible for you to carry on the marital relationship ?

A. Yes.

DONALD GRAHAM, being duly sworn according to law, testified as follows:

BY MR. BLAKLEY:

Q. Would you state your name sir ?

A. Donald Graham.

Q. And where do you reside, Mr. Graham ?

A. 6½ Overdorf Ave.

Q. Do you know Mildred May, the plaintiff in this action ?

A. Yes, I do.

Q. Are you acquainted with her husband, Richard May ?

A. Not personally.

Q. In what way are you acquainted with him ?

A. Well, I do know that he has been going with - well, she was my daughter-in-law.

Q. You mean this girl that Mr. May has been running with used to be your daughter-in-law ?

A. That's right.

Q. Do you know when he first started going with her ?

A. Not the exact date, no.

Q. Approximately when ?

A. I would say sometime the latter part of August or first part of September.

Q. 1960 ?

A. Yes.

Q. Was she still married to your son at that time ?

A. She wasn't.

Q. Have they subsequently been divorced ?

A. She divorced him final two weeks ago.

Q. And was Mr. May running with your former daughter-in-

law the cause of their divorce ?

A. I would think so.

Q. Is it generally known around town that Mr. May is running with this woman ?

A. Common knowledge as far as I know.

Q. In other words, many of your acquaintances and acquaintances of Mr. May know that ?

A. Oh, Yes.






