CAUSES OF DIVORCE

The Plaintiff alleges:

- a. Indignities to the person, and
- b. Desertion by the Defendant from April 21, 1955.

IV

FINDINGS OF FACT

1. Marriage: The Plaintiff and Defendant were married on September 16, 1942 by Reverend Oakes, a Salvation Army Chaplain at Clearfield, Pennsylvania.

2. Residence: The Plaintiff is a resident of Clearfield County, Pennsylvania since 1955. The Defendant is also a resident and citizen of Clearfield County since 1955.

3. Citizenship: Both Plaintiff and Defendant are citizens of Pennsylvania and the United States of America.

4. Age and Occupation: The Plaintiff is 37 years of age and a nurses' aid by occupation; the Defendant is 39 years of age and is a laborer by occupation.

5. Children: Three children were born to this marriage and are presently residing with the Defendant.

a. Nancy Louise Ardery, age 18 years of R. D. Osceola Mills, Pennsylvania.

b. Russell Robert Ardery, age 16 years of R. D. Osceola Mills, Pennsylvania.

c. James Albert Ardery, age 7 years of R. D., Osceola Mills, Pennsylvania.

6. Military service: Neither the Plaintiff nor the Defendant are members of the armed forces of the United States of America.

7. Findings on the merits:

- (a). That both parties are *sui juris*.
- (b). That the Plaintiff and the Defendant were married on September 16, 1942.
- (c). The Plaintiff is a resident of Clearfield County, Pennsylvania.
- (d). That three children were born to this marriage and reside with their father, the Defendant at R.D. Osceola Mills, Pennsylvania.
- (e). The Defendant willfully and maliciously deserted the Plaintiff, the injured and innocent spouse without reasonable cause on and from April 21, 1955 to and including the present time, which exceeds the term of space of two years continuous desertion.
- (f). The Plaintiff is the injured and innocent spouse and is entitled to a divorce on the grounds of desertion.

8. Discussion: The Divorce Law provides a cause of divorce in favor of the innocent and injured spouse, where the other spouse "shall have committed wilful and malicious desertion and absence from the habitation from the injured and innocent spouse, without a reasonable cause and for the term and space of two years." In the instant proceedings the Plaintiff alleges and testifies that the Defendant wilfully and maliciously deserted the Plaintiff on April 21, 1955.

The evidence and testimony presented supported both the cause of divorce on the grounds of desertion and indignities but the Master is confining his recommendation on the grounds of desertion solely.

The Defendant had no just cause for removing the Plaintiff and refusing her the right to live with the Defendant from April 21, 1955 to the present time. It is apparent from the testimony

that the Defendant no longer considered the vows of marriage when he removed forcibly the Plaintiff from the couple's home as he was consorting with Pearl Ann Coder at the time. This course of conduct had existed prior to the said separation and also for some time afterwards. The separation was caused by the Defendant's conduct and due to circumstances beyond the control of the Plaintiff and which the Defendant was completely to blame. Desertion results where one is excluded from the home by the other spouse, wilfully and without justification. See Foley vs. Foley 188 Pa. Superior 292.

The period of desertion has been persisted in for over a period of two years as required by the divorce law. No bona fide offer of reconciliation has been made by the Defendant whereby the period of desertion might be broken. On the contrary, the Defendant has continued to absent himself from the Plaintiff without just cause since April 21, 1955.

V

CONCLUSIONS OF LAW

1. That the proceedings are regular and conform to the rules and to the Act of Assembly.
2. That the evidence presented shows that the Defendant deserted the Plaintiff on April 21, 1955.
3. The Plaintiff is a citizen and a resident of Clearfield County, Pennsylvania and has resided in Clearfield County for more than two years. The Defendant is a citizen and a resident of the Commonwealth of Pennsylvania and his present address is R. D., Osceola Mills, Pennsylvania.

4. That all process has been served personally upon the Defendant.


5. That under the evidence presented, the Plaintiff is entitled to a decree of divorce a vinculo matrimonii.

VI

RECOMMENDATION

The Master recommends that a decree be entered by your Honorable Court divorcing and separating the said parties from the society, fellowship and company of each other as fully as if they had never been married or as if the said respondent were dead. A form of decree to that effect is hereto attached.



MASTER'S HEARING

The Master's Hearing was held at the office of John B. Gates, Esq., in the County National Bank Building, Friday, July 7, 1961, at 11:00 A.M., EDST. The following persons appeared: Loretta Lelia Ardery, Plaintiff; Oma Logan, witness for the Plaintiff; and M.L. Silberblatt, Esq., Attorney for the Plaintiff.

LORETTA LELIA ARDERY, being duly sworn testifies as follows:

BY MR. SILBERBLATT:

Q. Your name is Loretta Lelia Ardery?

A. Yes.

Q. Were you married to Russell Emanuel Ardery?

A. Yes.

Q. When were you married?

A. On September 16, 1942.

Q. Before you were married, how long had you known him?

A. About nine months.

Q. At the time you and Russell got married, where was your home?

A. At R. D. #2, Clearfield, Pennsylvania.

Q. What was the address of your husband at that time?

A. R. D. #2, Clearfield, Pennsylvania. Just across the way.

Q. After you were married, where did you go?

A. With my husband's people--Mr. and Mrs. Levi Ardery at R. D., Clearfield, Pennsylvania.

Q. How long did you live with his people?

A. From the time we were married until my husband came back from the service.

Q. When did he come back from the service?

A. In September of 1943.

Q. When he came back from the service, where did you live?

A. At the crossroads, Clearfield, R. D. #2.

Q. Is that Kerr Addition?

A. Yes.

Q. How long did you live in Kerr Addition with your husband?

A. Just a few months. Then he started to run around.

Q. Did you move around from place to place in Lawrence Township for a period of time?

A. Yes.

Q. You never lived any place outside of Lawrence Township?

A. Yes, we lived in Bradford Township. Then we moved to Curwensville, then back to Bradford Township.

Q. You lived your entire married life in Clearfield County?

A. Yes.

Q. Are you a citizen of the United States?

A. Yes.

Q. Where were you born?

A. In Bradford Township, Woodland, R.D.

Q. Is your husband a citizen of the United States?

A. Yes.

Q.

Q. Where was he born?

A. He was born in Clearfield County, but moved to Johnstown.

Q. At the time you were married, did he live in Clearfield County?

A. Yes.

Q. What is your age?

A. I was 37 years old on February 21.

Q. What is your occupation?

A. I am a nurses' aid.

Q. What is the age of your husband?

A. He was 39 years of age on June 9.

Q. What is his occupation?

A. He is a laborer.

Q. Were there any children born to this marriage?

A. Yes, three.

Q. What is the name of the oldest?

A. Nancy Louise Ardery, age 18 years, born June 13, 1943.

Q. Where does she live?

A. They're all with their dad? This summer she is with her Aunt Alice.

A. What is the name of the next one?

Q. Russell Robert Ardery, age 16 years, born on the 26th day of June, 1945.

A. Where does he live?

Q. With his father.

A. The next one?

Q. James Albert Ardery, age 7 years, born November 3, 1953.

Q. Where does he live?

A. With his father.

Q. Their father lives at Osceola Mills?

A. Yes.

Q. Was your husband ever in the service of the United States?

A. Yes.

Q. When did he go in?

A. On December 9, 1942, and was discharged in 1943.

Q. Is he in the service at the present time?

A. No.

Q. Did you and your husband have any trouble?

A. Yes, we did.

Q. When did your trouble commence?

A. It started right after he went to the service, but I didn't believe it.

Q. Did you and your husband separate?

A. Yes, we did.

Q. Do you remember the date?

A. April 21, 1955.

Q. What did he do on that date?

A. He put the baby and I out.

Q. What did he say to you?

A. He just told me to take Jimmie and get out. That we couldn't come back.

Q. Did you get out?

A. Yes.

Q. Where did you go?

A. Down to Lillian Cutler's, who lived near us.

Q. Did he ever ask you to come back?

A. No.

Q. Did he ever write to you?

A. No.

Q. Did you ever bring proceedings against your husband for non-support?

A. Yes.

Q. In that proceedings did you state that he deserted you on the Fifth day of July, 1955? Is that correct?

A. Yes.

Q. When was the date that he left you?

A. April 21, 1955.

Q. The proceedings that was filed states that the desertion took place on July 5, 1955. Is that the truth?

A. No. July 5 is the date that I had him arrested but he actually deserted me on April 21, 1955.

We offer now in evidence the papers of the Commonwealth against Russell against Russell Ardery entered at 62 September Quarter Sessions, 1 1955.

Q. Why does your husband have the children?

A. I was awarded custody of the three children by Judge Pentz after our separation and when I had the children my husband didn't pay for them. I was working at that time and my three children were staying with my father. My father was unemployed and was unable to support the children by himself and with my help as we were getting nothing from my husband towards the support of the children, and which there is still a large arrearage appearing on the Probation Office records. At the suggestion of my father, who was financially unable to support the children and due to the fact that I did not have sufficient financial ability, the children were returned to their father, who lives at Osceola Mills, in

November of 1956.

Q. Did you do everything you could do to make your married life a happy one?

A. I hope so.

Q. Were you a good and dutiful wife?

A. I hope so.

Q. Do you have any idea why your husband ordered you out of the house?

A. I wouldn't put up with him running around that way.

Q. After he ordered you out of the house, did he bring anyone into the house?

A. No.

Q. Is there any agreement between you and your husband to get this divorce?

A. No, absolutely no.

BY THE MASTER:

Q. Mrs. Ardery, at the time your husband put you out of the house, do you know who he was running around with?

A. Yes, he was running with a Pearl Ann Coder, who lives in Kerr Addition.

Q. How many times a week was he running with her?

A. He was there all the time--he was never home.

Q. Did he continue to run around with her after he put you out of the house?

A. Yes, until sometime later.

Q. Mrs. Ardery, when was the last time you and your husband lived together as husband and wife?
about

A. In 1955, /April 1.

Q. Has your husband made any overtures to you to effect a reconciliation?

A. No.

Q. Where are you living at the present time?

A. At the present time I am working at 629 Nichols Street, at Silas J. Manns'.

Q. Did the Order of Court provide for support for the children and yourself?

A. No, he told Judge Pentz he would only pay for the children but nothing for me. He just paid a couple of weeks.

Q. Did you give your husband any grounds for ordering you out of the house?

A. I don't think so.

MRS. OMA LOGAN, being duly sworn, testifies as follows:

BY MR. SILBERBLATT:

Q. Is your name Oma Logan?

A. Yes.

Q. Are you related to Loretta Lelia Ardery?

A. I am her mother.

Q. Do you know that she is married to Russell Ardery?

A. Yes.

Q. Do you know whether they are separated or not?

A. Yes, they are.

Q. Do you know when that was?

A. Early in the spring of 1955.

A. Yes.

Q. Do you know what happened on the day your daughter separated from her husband?

A. She called and said that he put her out.

Q. Did she tell you where to pick her up?

A. At Cutler's.

Q. Did you go to Cutler's to pick her up?

A. We went to the path that came from the Cutler home and we took her and the child with us.

Q. Has your home been her home ever since that?

A. Yes.

Q. Do you know if her and her husband have any agreement to get this divorce?

A. No, they have not.
