


The Petition of KAY THOMPSON WALKER, by her attorney,

3. That Kay Thompson Walker, formerly Kay Thompson Brunetti and Albert R. Brunetti were divorced by the Court of Clearfield County, Pennsylvania on October 19, 1957.
4. That your Petitioner has since remarried with Robert Walker and is residing in North Hollywood, California and have their home there. The said Albert R. Brunetti has also remarried.


