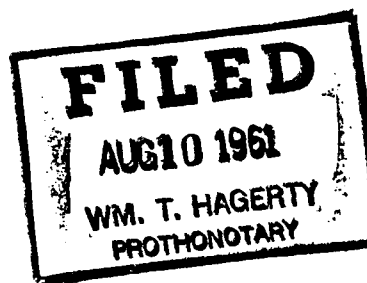

COMPLAINT

1. The Plaintiff is a partnership composed of Clyde S. Peterman and Sheldon E. Peterman which has its principal place of business at 805 Chestnut Avenue, Altoona, Blair County, Pennsylvania.

2. The Defendant is an individual residing at 122 Washington Avenue, DuBois, Pennsylvania.

3. That from June 19, 1958 until May 4, 1959, the Plaintiff at the oral request of the Defendant made repairs to and furnished parts for the motor vehicle of the defendant in the amount of \$2,768.32 as more fully set out in the invoices and statement hereto attached, marked Exhibit "A" and made a part hereof.

4. That the prices charged the Defendant by the Plaintiff were fair and reasonable at the time they were made and were the same as those charged other customers of the Plaintiff for the same parts and services and were the prices the Defendant agreed to pay for the same.

5. That the Defendant has made payments and is entitled to credits totalling \$1,990.10 so that there remains a balance due the Plaintiff of \$778.22.

6. The Plaintiff has demanded payment from the Defendant of the amount due, but Defendant has refused and still refuses to pay the same or any part thereof.

WHEREFORE, Plaintiff demands judgment against the Defendant in the amount of \$778.22 with interest from June 4, 1959.
