agree that there is occasion for such road, they shall proceed to lay out the same, as the desire of the petitioners as may be, having respect for the best ground for a road, and the shortest distance, in such manner as to do the least injury to private property; and shall make report thereof, stating particularly whether they judge the same necessary for a public or private road, together with a plot or draft thereof, and the courses and distances, with reference to the improvements through which it may pass, to the next Court of Quarter Sessions to be held for said county. In which report they shall state that they have been sworn or affirmed according to law.

We the persons appointed to review the road within mentioned and parts adjacent do report; That in pursuance of the said order, we after giving due timely and legal notice and being duly sworn did review the same and have laid out for private use the following road, to wit: beginning at the north East corner thence South 2 West 25 per. to J. P. & P. B. cor thence North 88 West 126 per. to M. B. C. & J. P. cor thence North 2 East 28½ per to intersection of Big Basin Road. This being the shortest and the best Road which can be gotten without injuring private property. And this having been the outlet of some of the neighbors for the last eight years

March 16th 1878 D. Askey files Exceptions to the Commission of this Report, - as follows: -

Exp. 1. - The order from the Court is an original Road order and not an order of Review, - and it is ~~to~~ to be presumed that ^{the review} they discharged their duties according to the Command of the Order.

Exp. 2. It does not show notice to the owner or occupants of Seated Lands through which the road is laid out. -

Exp. 3. The report does not say any thing about damages. It is not true that the route reported is the shortest and best road which can be gotten between the points called for in the Order.

Exp. 4. The report of the former view gives a much shorter route, with an easier and better grade and over ground that has been heretofore for a long time used as a road. And does therefore should not be set aside for the road reported in this review which is much longer and worse grade and which does not accommodate the people for whose benefit a road is sought between these points.

Exp. 5. The road reported does not conform to the order in this, that it does not intersect the big basin road near the Fairmount school house in Covington Township but at the distance of one third of a mile from it while the entire distance between the points to be connected under the order is less than two thirds ($\frac{2}{3}$) of a mile that is to say about 191 Perches by the former view while the present road as laid out in this report would make the distance to be traveled about 291 perches.
