To the Hon. Judges within named
are the undersigned persons appointed
by the within Order of Court, to view
the site for a Bridge, therein mentioned,
respectfully report. That having given
Notice of the time and place of meeting, ac-
cording to the Act of Assembly, we met
on the Ground proposed for the said
Bridge, on the 4th of Nov. 1880, and one of
the viewers, not being present, we adjourned,
and met again on the 11th day of January 1881.
And being all present, at the view of the site
proposed for the said Bridge, and being all
sworn, or affirmed, in pursuance of the
said Order, we have viewed the said site
proposed for the said Bridge, and find,
that the location is a very favorable one.
And we are of opinion that a Bridge at
that point is necessary for public use.

The Bridge in our opinion should be built
at least sixteen (16) feet high, above low
water mark. and would require a span
one hundred and eight (108) feet in length.
And although stone for abutments,
and material for filling the same con-
venient, we are of opinion that
the expense of building said Bridge,
would be too great and burdensome

for the inhabitants of one Township,
we would recommend that County as-
sist them in building said Bridge.

Clearfield County, Pa.

At a Court of Quarter Sessions of the Peace of the county of Clearfield, held at Clearfield, in and for said county, on the 7th day of October A. D. 1880, before Judges of said Court, upon a petition of sundry inhabitants of the Township of Isell

in said county, setting forth that a Bridge is much wanted over the Susquehanna River at the place where the public highway now crosses the said river at or near Hyde's Bridge in the Township of Isell aforesaid the said place being frequently rendered impassable by reason of ice and high water and that the expense of erecting said Bridge would be to heavy and burden some upon the inhabitants of said Township

and therefore praying the Court to appoint proper persons to view and lay out the same according to law,

whereupon the Court, upon due consideration had of the premises, do order and appoint S. S. McCloskey Robert Mahaffey & J. W. McGehee who, after being respectively sworn or affirmed to perform the duties of their appointment with impartiality and fidelity, are to view the grounds proposed for said Bridge and if they view the same and any two of the actual viewers agree that there is occasion for such Bridge, they shall proceed to lay out the same agreeable to the desire of the petitioners, as may be, having respect to the best ground for a road and the shortest distance, and in such manner as to do least injury to private property, and state particularly whether they judge the same necessary for a public or private road, together with a plot or draft of the same, with the courses and distances and reference to the improvements through which it passes, and shall also procure releases of damages from persons through whose lands said road may pass, or failing to procure such releases, shall assess the same, if any sustained, and shall make report thereof to the next Court of Quarter Sessions to be held for the said county, in which report they shall state that they have been sworn and affirmed according to law. Notice is directed to be given to the owners or occupants of seated lands through which the within road is intended to pass, of the time of the view, according to the 147th rule of Court.

Also— Viewers will carefully note the number of days employed and set the amount out at the foot of their return.

Reviewers cannot interfere with damages assessed by the original viewers, except so far as the location may be changed by the reviewers.

N. B.—If the viewers believe the parties are not entitled to damages, taking into consideration the advantages as well as the disadvantages of the road, they will report to that effect.
