ORDER OF EXPUNGEMENT

NOW, this _____th day of May 2024, the Defendant having successfully completed the ARD Program, with all Fines, Costs and Restitution paid in full, on the charges of **Driving Under the Influence (M)** and being entitled to dismissal on the offenses as set forth above, it is the ORDER of this Court that the Defendant is discharged on the offenses as set forth above and the record of the offenses be and are hereby expunged. It is the further ORDER of this Court that as to any charges to the above-captioned term and number which remain undisposed, that a Nolle Prosequi be entered and the same are expunged. It is ORDERED that the Clerk of Courts shall serve a certified copy of this Order upon the following persons, the keepers of records pertaining to the above-captioned criminal proceedings: District Attorney's Office, Clerk of Courts, Adult Probation Office, Pennsylvania State Police, Court Administrator's Office, the Issuing Authority, Arresting Agency and all Court Reporters who may have taken proceedings in this case.
